- In order to contribute to the fight against climate change, carrying out activities to increase the share of renewable energy sources in total energy consumption, reducing our energy use through energy efficiency practices, measuring our greenhouse gas emissions in all areas in which we operate, setting targets for reduction and implementing projects, playing an active role in the green transformation of our country,
- Continuously controlling and improving our processes and contributing to the circular economy in order to protect the environment and biodiversity by reducing our ecological footprint throughout our value chain,
- Taking all measures in the light of the best health and safety standards to provide a working environment with decent conditions,
- Preventing discrimination in all our processes and creating opportunities for the employment of women, youth and disadvantaged groups,
- Offering equal opportunities to our employees in every field, conducting recruitment, career development and promotion processes in a transparent and fair manner,
- Regularly evaluating the opinions and suggestions of our employees in order to keep their satisfaction levels at the highest level, and taking the necessary remedial actions,

- Increasing our product and service quality with a perspective of continuous improvement, and taking remedial actions to ensure customer satisfaction, one of our highest priorities,
- Together with IC İbrahim Çeçen Foundation, within the scope of our corporate social responsibility projects, supporting the society and our stakeholders, especially in the fields of education, health, sports and arts collaborating with different institutions and organizations in the regions where we operate, and undertaking training and development activities to raise awareness and develop competencies in the field of sustainability,
- Adopting sustainable supply chain practices in our procurement processes and supporting the development of our suppliers in this regard,
- Regularly reviewing our activities and processes in the field of sustainability, setting goals and targets in the light of identified risks and opportunities, and regularly communicating our sustainability performance with all our stakeholders in the light of international standards' transparency and accountability principles.

This policy is reviewed periodically and updated when deemed necessary. Corporate Governance Committee is responsible for updating the policy.

This Policy and any changes made to it shall enter into force on the date of approval by the Board of Directors.
